COVID-19 Vaccine Distribution and Clinics



New Development Regarding Distribution and Priority Groups

For about a month now, CCPH has administered COVID-19 vaccines to healthcare workers, first responders and 70+. Moving forward, we will be streamlining our vaccine distribution processes to accommodate *only* the current authorized groups. There have been instances when people outside of these groups have received the vaccine due to necessity for using time-sensitive doses. Unfortunately, the honor system has been abused over the past week and has caused excessive traffic, as well as ethical and logistical concerns.

With that said, we will be releasing additional slots only for the authorized groups named above. Please be thoughtful of others and do not show up to a clinic at the Chaffee County Fairgrounds unless you have an appointment for a vaccine.

Moving forward for extra doses that need to be used immediately, we will only be lining up 10 people max, in vehicles, who fall within the authorized groups.

It's important to know that we rely on personal accountability and responsibility in order to fulfill the state's mandate and milestone of 70% of 70 and older by Sunday, Feb 28. However, due to limited inventory and disparities across the state, it is possible that when Chaffee County reaches this mark, the vaccine program may be required to pause while the rest of the state catches up.

Thank you for your patience as we continue to follow the governor's direction on vaccine distribution across the state. As soon as we are given the green light to transition to other groups, we will schedule more clinics for first doses.

Please know that we care about you and are continuously striving toward the end goal of ending this pandemic.

Other Key Items to Note in Regard to COVID-19 Vaccines through CCPH:

- The scheduler for your second dose will be open the day after you receive your first dose. Please schedule your second dose using the [electronic scheduler](#).
- Our clinics are for Chaffee County residents only.
- In order to receive a vaccine through CCPH, you must have an appointment.
- Currently, CCPH's vaccination events are drive-through clinics held on Mondays and Tuesdays from 1-4 p.m.
- It is important to schedule a second dose through the scheduler using the date on the white CDC card received at the first appointment. The appointment does not replace the online scheduler. There are specific dates and slots available for second doses.

Colorado Launched a New COVID-19 Vaccine Hotline



On Monday, Jan. 25, CDPHE launched a new call center for the public to ask questions specifically about the COVID-19 vaccine.

The new toll-free number is 1-877-CO VAX CO (1-877-268-2926).

Now through the end of January, the vaccine call center is open Monday through Friday, 9 a.m.-10 p.m., as well as from 9 a.m -5 p.m. on Saturdays and Sundays.

Beginning Feb. 1, hours will extend to 24 hours a day, seven days a week.

Vaccine call center staff are available to answer COVID-19 vaccine-related questions, provide info about vaccine providers across the state, and give general information about COVID-19.

**We are no longer testing on Fridays.*

We were recently informed by CDPHE that we will need to change our testing criteria for the short-term future and our laboratory services for the long-term future. We appreciate your patience as we transition to a new testing option.

When to test?

- If you have symptoms, we recommend you get tested at the first available opportunity. Please remain isolated until you receive your test result.
- If you were a close contact, but have no symptoms, we recommend testing 6-7 days after exposure. If you have remained without symptoms the entire time since exposure and test on day 6 or later, your quarantine is considered complete after day 7, as long as your test result is negative. Test results take up to 4 days.
- Quarantine NEVER ends before day 7. Quarantine can end on day 8, 9 or 10, if you have a negative test from day 6 or thereafter.

What to Do if You Test Positive

Positive cases are in isolation until they meet the criteria to be released. Please read this [ISOLATION LETTER](#) and follow the instructions.

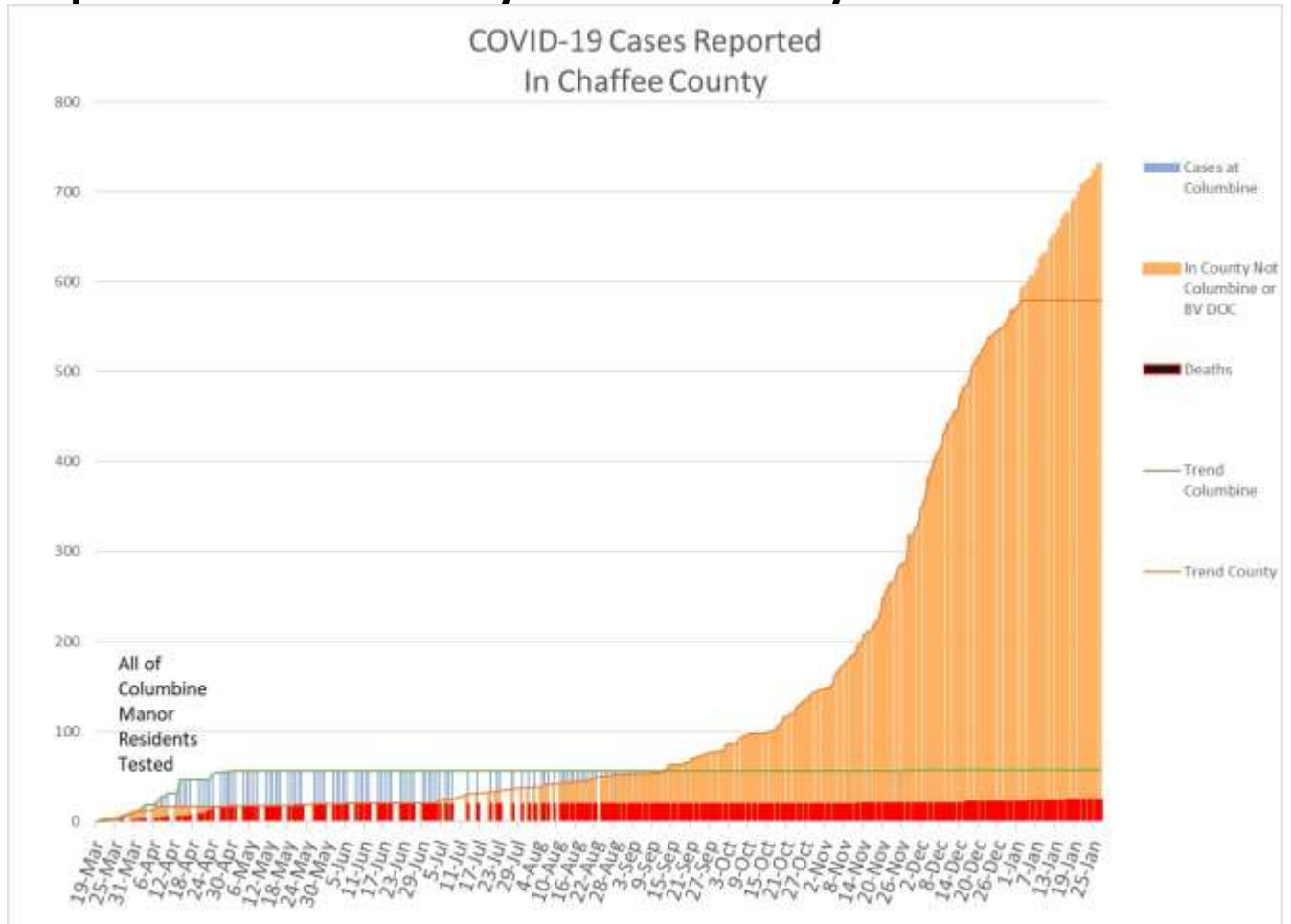
- Individuals with a positive case need to begin contacting their close contacts and employer. A close contact is anyone who was within 6 feet of the positive case for 15 minutes or more in total over 24 hours, beginning 48 hours before symptoms (or a positive test if without symptoms).
 - Please send your close contacts this [QUARANTINE LETTER](#).
- You will be contacted by a contact tracer within a few days.

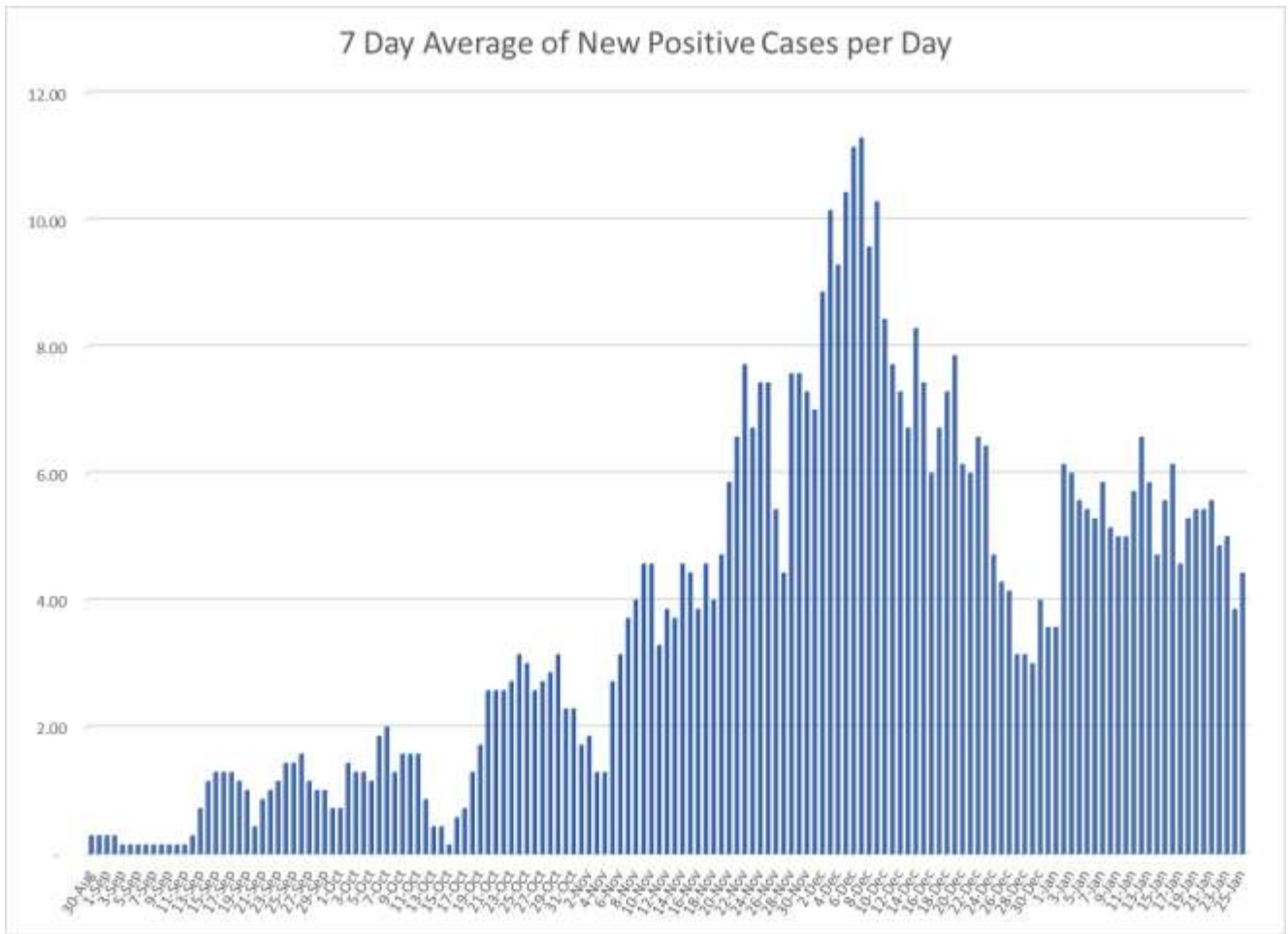
Graphs of COVID-19 Activity in Chaffee County



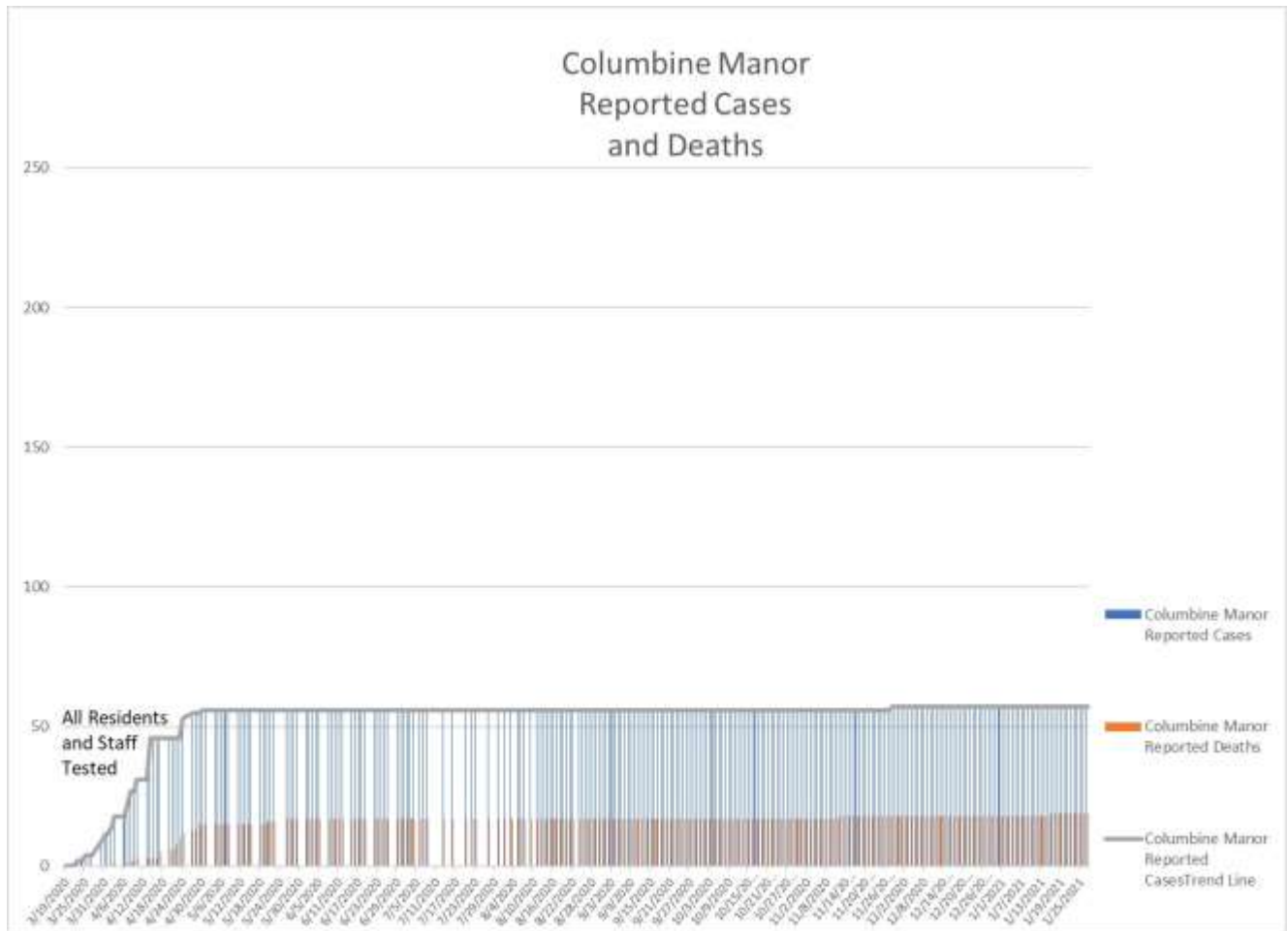
This graph shows all of the reported positive COVID-19 cases in Chaffee County.

COVID-19 Case/Vaccine Summary for Colorado:



- 727 cases reported Jan. 25.
- 5 new deaths among cases reported since Jan. 25.
- 674 people currently hospitalized for confirmed COVID-19 as of Jan. 26.
- 5.10% is the 7-day moving average positivity.
- 381,402 people immunized with one dose as of Jan. 25.
- 89,881 people immunized with two doses as of Jan. 25.
